



# Clinical Policy: Ambulatory Withdrawal Management Without Extended Onsite Monitoring (ASAM 1 WM)

## **Description:**

Ambulatory Withdrawal Management (WM) without Extended On-Site Monitoring is an organized outpatient service that provides medically supervised evaluation, withdrawal management, and referral in a licensed facility. Services are provided in regularly scheduled sessions to be delivered under a defined set of policies and procedures or medical protocols.

This is an American Society of Addiction Medicine (ASAM) Criteria, Third Edition Level 1 WM service for a Member who is assessed to be at minimal risk of severe withdrawal, free of severe physical and psychiatric complications, and can be safely managed at this level. These services are designed to treat the Member's level of clinical severity and to achieve safe and comfortable withdrawal from alcohol and other substances to effectively facilitate the Member's transition into ongoing treatment and recovery.

## **Definition:**

Clinical Institute Withdrawal Assessment of Alcohol Scale (CIWA-AR) is defined as a tool used to assess an individual's alcohol withdrawal

## **The ASAM Criteria, Third Edition**

The American Society of Addiction Medicine Criteria is a comprehensive set of treatment standards for addictive, substance-related, and co-occurring conditions. The ASAM Criteria, Third Edition uses six dimensions to create a holistic, biopsychosocial assessment to be used for service planning and treatment. The six dimensions are:

1. Acute Intoxication and Withdrawal Potential;
2. Biomedical Conditions and Complications;
3. Emotional, Behavioral, or Cognitive Conditions and Complications;
4. Readiness to Change;
5. Relapse, Continued Use, or Continued Problem Potential; and
6. Recovery and Living Environment.

## **Policy/Criteria<sup>1</sup>**

- I. WellCare of North Carolina® shall cover medically necessary Ambulatory Withdrawal Management without Extended On-site Monitoring services when the Member meets the following specific criteria:

- A. Has a substance use disorder (SUD) diagnosis as defined by the current DSM-5 edition, or any subsequent editions of this reference material; **AND**
- B. Meets the American Society of Addiction Medicine (ASAM) Level 1 WM Ambulatory Withdrawal Management without Extended On-Site Monitoring admission criteria as defined in The ASAM Criteria, Third Edition, 2013.

#### II. Admission Criteria

- A. Due to the nature of this crisis service, a Comprehensive Clinical Assessment (CCA) and Diagnostic Assessment (DA) is not required before admission to Ambulatory Withdrawal Management without Extended On-Site Monitoring services.
- B. The physician or physician extender shall conduct an initial abbreviated assessment and physical exam, including a pregnancy test as indicated, to establish medical necessity for this service and develop a service plan as part of the admission process.
- C. The initial abbreviated assessment (Reference 10A NCAC 27G .0205(a)) must consist of the following information:
  - 1. the Member's presenting problem;
  - 2. the Member's needs and strengths;
  - 3. a provisional or admitting diagnosis;
  - 4. a pertinent social, family, and medical history; and
  - 5. other evaluations or assessments.
- D. The program physician or physician extender can bill Evaluation and Management codes separately for the admission assessment and physical exam.
- E. Within three (3) calendar days of the admission, a comprehensive clinical assessment must be completed by a licensed professional to determine an ASAM level of care for discharge planning. Information from the abbreviated assessment is utilized as a part of the current comprehensive clinical assessment. Relevant diagnostic information must be obtained and documented in the treatment or service plan.
- F. Evaluation and Management CPT codes, the comprehensive clinical assessment, individual therapy, laboratory tests, and toxicology tests are billed separate from the Ambulatory Withdrawal Management without Extended On-Site Monitoring service.

#### III. Continued Stay and Discharge Criteria

- A. The Member meets the criteria for continued stay if any **ONE** of the following applies:
  - 1. The withdrawal symptoms have not been sufficiently resolved to allow either discharge to a lower level of care or safe management in a less intensive environment; **OR**
  - 2. The CIWA-Ar score (or other comparable standardized scoring system) has not increased or decreased.
- B. The Member meets the criteria for discharge if any **ONE** of the following applies:
  - 1. The withdrawal signs and symptoms are sufficiently resolved so that the Member can participate in self-directed recovery or ongoing treatment without the need for further medical or nursing withdrawal management monitoring;

2. The signs and symptoms of withdrawal have failed to respond to treatment and have intensified (as confirmed by higher scores on the Clinical Institute Withdrawal Assessment for Alcohol Scale, Revised (CIWA-Ar) or other comparable standardized scoring system) indicating a need for transfer to a higher level of care;
3. The Member is unable to complete withdrawal management at Level 1 WM, indicating a need for more intensive services; **OR**
4. The Member or person legally responsible for the Member requests a discharge from the service.

#### IV. WellCare of North Carolina® shall NOT cover these activities:

- A. Transportation for the Member or member's family is not billable under Ambulatory Withdrawal Management Without Extended Onsite Monitoring (ASAM 1WM), program
- B. Medically necessary transportation for medical appointments may be covered under WellCare of North Carolina® Non-Emergency Medical Transportation benefit. Please refer to Clinical Coverage Policy WNC.CP.262 "Non-Emergency Medical Transportation," available at [WellCare NC Clinical Coverage Guidelines](#) for prior authorization information. Medicaid Transportation information, for WellCare of North Carolina members, is available at [WellCare NC Medicaid Transportation Services](#).
- C. Any habilitation activities;
- D. Time spent doing, attending, or participating in recreational activities unless tied to specific planned social skill assistance;
- E. Clinical and administrative supervision of Level 1 WM staff, which is covered as an indirect cost and part of the rate;
- F. Covered services that have not been rendered;
- G. Childcare services or services provided as a substitute for the parent or other individuals responsible for providing care and supervision;
- H. Services provided to teach academic subjects or as a substitute for education personnel;
- I. Interventions not identified on the Member's service plan;
- J. Services provided to children, spouse, parents, or siblings of the Member under treatment or others in the Member's life to address problems not directly related to the Member's needs and not listed on the service plan; and
- K. Payment for room and board.

#### Background<sup>1</sup>

##### I. Prior Approval

- A. Medicaid shall not require prior approval for Ambulatory Withdrawal Management Without Extended Onsite Monitoring upon admission through the first three (3) calendar days of services.

#### II. Utilization Management

- A. Utilization management of covered services is a part of the assurance of medically necessary service provision. Authorization, which is an aspect of utilization management, validates approval to provide a medically necessary covered service to an eligible Member. All utilization review activity must be documented in the service record and be maintained by the program.
- B. Services are based upon a finding of medical necessity, must be directly related to the Member's diagnostic and clinical needs, and are expected to achieve the specific rehabilitative goals detailed in the Member's service plan. Medical necessity is determined by North Carolina community practice standards, by 10A NCAC 25A .0201, as verified by WellCare of North Carolina®, who evaluates the request to determine if medical necessity supports intensive services.
- C. Medically necessary services are authorized in the most cost-effective modes, if the treatment that is made available is similarly effective as services requested by the Member's physician, therapist, or another licensed practitioner. The medically necessary service must be recognized as an accepted method of medical practice or treatment.

#### III. Initial Authorization

- A. To request an initial authorization, the CCA or DA, service order for medical necessity, the service plan, and the required authorization request form must be submitted to WellCare of North Carolina® within the first three (3) calendar days of service initiation..

- IV. **Concurrent reviews** will determine the ongoing medical necessity for the service or a lower or higher level of care. Providers shall submit, an updated service plan and any authorization or reauthorization forms required by WellCare of North Carolina® .including documentation demonstrating continued medical necessirt for the member to continue treatment at the requested ASAM level of care..

#### V. Additional Limitations or Requirements

- A. A Member shall receive the Ambulatory Withdrawal Management without Extended On-Site Monitoring service from only one provider organization during any active authorization period.
- B. Ambulatory Withdrawal Management without Extended On-Site Monitoring services may not be provided on the same day as Substance Use Disorder Withdrawal Management or Residential Services, except on day of admission or discharge.

#### VI. Service Orders

A service order is a mechanism to demonstrate medical necessity for a service and is based upon an assessment of the Member's needs. A signed service order must be completed by a physician, physician assistant, or nurse practitioner, according to their scope of practice.

A service order is valid for 12 months. Medical necessity must be revisited, and service must be ordered at least annually, based on the date of the original service order.

**A. ALL the following apply to a service order:**

1. Backdating of the service order is not allowed;
2. Each service order must be signed and dated by the authorizing professional and must indicate the date on which the service was ordered; **AND**
3. A service order must be in place before or on the first day that the service is initially provided, to bill Medicaid for the service. Even if the Member is retroactively eligible for Medicaid, the provider cannot bill Medicaid without a valid service order.

#### **VII. Documentation Requirements**

- A.** The service record documents the nature and course of a Member's progress in treatment. To bill Medicaid, providers must ensure that their documentation is consistent with the requirements contained in this policy. The staff member who provides the service is responsible for accurately documenting the services billed to and reimbursed by Medicaid. Service notes must meet the requirements of the DHHS Records Management and Documentation Manual. Medication administration records (MAR) or electronic MARs must meet requirements of 10A NCAC 27G .0209 (c)(4).

#### **VIII. Program Requirements** (For additional program requirements not listed here, please refer to North Carolina Medicaid State Policy Site for Clinical Coverage Policy No: 8A-7 Ambulatory Withdrawal Management Without Extended Onsite Monitoring (ASAM 1WM), Section 6.0 at [Program Specific Clinical Coverage Policies | NC Medicaid \(ncdhhs.gov\)](https://www.ncdhhs.gov/Program-Specific-Clinical-Coverage-Policies)).

- A.** Ambulatory Withdrawal Management without Extended On-Site Monitoring is an organized outpatient service that provides medically supervised evaluation, withdrawal management, and referral services according to a predetermined schedule. Services are provided in regularly scheduled sessions to be delivered under a defined set of policies and procedures or medical protocols.
- B.** Required components of this service must contain the following:
1. A comprehensive clinical assessment within three (3) calendar days of admission;
  2. An initial assessment including an addiction focused history and physical examination, including a pregnancy test, as indicated, at admission by a physician or physician extender;
  3. A nursing evaluation upon admission;
  4. Individualized service plan;
  5. Daily assessment of progress during withdrawal management and any treatment changes;
  6. Ability to conduct or arrange for laboratory and toxicology tests, which can be point-of-care testing;

7. Provide education to Member regarding prescribed medications, potential drug interactions and side effects;
8. Medically necessary clinical services including individual therapy, as indicated;
9. Arranges involvement of family members or significant others in the withdrawal management process, and with informed consent;
10. Availability of specialized psychological and psychiatric consultation and supervision for biomedical, emotional, behavioral, and cognitive problems, as indicated;
11. Provide crisis interventions, when clinically appropriate;
12. Provide 24-hour access to emergency medical consultation services;
13. Provide education to family members or significant others regarding withdrawal management process;
14. Ability to assist in accessing transportation services for a Member who lacks safe transportation;
15. Provide linkage and coordination with care management;
16. Affiliation with other ASAM levels of care and behavioral health providers for linkage and referrals for counseling, medical, psychiatric, and continuing care; and
17. Discharge planning beginning at admission.
18. Program medical staff shall be available to provide 24-hour access for emergency medical consultation services, in-person or virtually.
19. This facility must be in operation a minimum of eight hours per day, all five weekdays (Monday through Friday), and a minimum of four hours daily on the weekend (Saturday and Sunday). The hours of operation must be extended based on member need. This service must be available for admission seven days per week. Program medical staff shall be available to provide 24-hour access for emergency medical consultation services, in-person or virtually.

#### IX. **Expected Outcomes**

- A. The expected clinical outcomes for this service are specific to recommendations resulting from clinical assessments, medical evaluation and meeting the identified goals in the Member's service plan. Expected outcomes are as follows:
  1. Reduction or elimination of withdrawal signs and symptomatology;
  2. Linkage to treatment services post discharge;
  3. Increased links to community-based resources to address unmet social determinants of health; **AND**
  4. Reduction or elimination of psychiatric symptoms, if applicable.

**North Carolina Guidance**

*Eligibility Requirements*

- a. An eligible beneficiary shall be enrolled in the NC Medicaid Program (Medicaid is NC Medicaid program, unless context clearly indicates otherwise);
- b. Provider(s) shall verify each Medicaid beneficiary’s eligibility each time a service is rendered.
- c. The Medicaid beneficiary may have service restrictions due to their eligibility category that would make them ineligible for this service.

*EPSDT Special Provision: Exception to Policy Limitations for a Medicaid Beneficiary under 21 Years of Age*

- a. 42 U.S.C. § 1396d(r) [1905(r) of the Social Security Act]  
 Early and Periodic Screening, Diagnostic, and Treatment (EPSDT) is a federal Medicaid requirement that requires the state Medicaid agency to cover services, products, or procedures for Medicaid beneficiary under 21 years of age if the service is medically necessary health care to correct or ameliorate a defect, physical or mental illness, or a condition [health problem] identified through a screening examination (includes any evaluation by a physician or other licensed practitioner).

This means EPSDT covers most of the medical or remedial care a child needs to improve or maintain his or her health in the best condition possible, compensate for a health problem, prevent it from worsening, or prevent the development of additional health problems.

Medically necessary services will be provided in the most economic mode, as long as the treatment made available is similarly efficacious to the service requested by the beneficiary’s

physician, therapist, or other licensed practitioner; the determination process does not delay the delivery of the needed service; and the determination does not limit the beneficiary's right to a free choice of providers.

EPSDT does not require the state Medicaid agency to provide any service, product or procedure:

1. that is unsafe, ineffective, or experimental or investigational.
2. that is not medical in nature or not generally recognized as an accepted method of medical practice or treatment.

Service limitations on scope, amount, duration, frequency, location of service, and other specific criteria described in clinical coverage policies may be exceeded or may not apply as long as the provider's documentation shows that the requested service is medically necessary "to correct or ameliorate a defect, physical or mental illness, or a condition" [health problem]; that is, provider documentation shows how the service, product, or procedure meets all EPSDT criteria, including to correct or improve or maintain the beneficiary's health in the best condition possible, compensate for a health problem, prevent it from worsening, or prevent the development of additional health problems.

#### **EPSDT and Prior Approval Requirements**

1. If the service, product, or procedure requires prior approval, the fact that the beneficiary is under 21 years of age does NOT eliminate the requirement for prior approval.

#### *Provider(s) Eligible to Bill for the Procedure, Product, or Service*

To be eligible to bill for the procedure, product, or service related to this policy, the provider(s) shall:

- a. meet Medicaid qualifications for participation;
- b. have a current and signed Department of Health and Human Services (DHHS) Provider Administrative Participation Agreement; and
- c. bill only for procedures, products, and services that are within the scope of their clinical practice, as defined by the appropriate licensing entity.

#### *Compliance*

Provider(s) shall comply with the following in effect at the time the service is rendered:

- a. All applicable agreements, federal, state and local laws and regulations including the Health Insurance Portability and Accountability Act (HIPAA) and record retention requirements; and

- b. All NC Medicaid's clinical (medical) coverage policies, guidelines, policies, provider manuals, implementation updates, and bulletins published by the Centers for Medicare and Medicaid Services (CMS), DHHS, DHHS division(s) or fiscal contractor(s).

#### *Claims-Related Information*

Provider(s) shall comply with the NC Tracks Provider Claims and Billing Assistance Guide, Medicaid bulletins, fee schedules, NC Medicaid's clinical coverage policies and any other relevant documents for specific coverage and reimbursement for Medicaid:

- a. Claim Type - as applicable to the service provided:
  - Professional (CMS-1500/837P transaction)
  - Institutional (UB-04/837I transaction)Unless directed otherwise, Institutional Claims must be billed according to the National Uniform Billing Guidelines. All claims must comply with National Coding Guidelines.
- b. International Classification of Diseases and Related Health Problems, Tenth Revisions, Clinical Modification (ICD-10-CM) and Procedural Coding System (PCS) - Provider(s) shall report the ICD-10-CM and Procedural Coding System (PCS) to the highest level of specificity that supports medical necessity. Provider(s) shall use the current ICD-10 edition and any subsequent editions in effect at the time of service. Provider(s) shall refer to the applicable edition for code description, as it is no longer documented in the policy.
- c. Code(s) - Provider(s) shall report the most specific billing code that accurately and completely describes the procedure, product or service provided. Provider(s) shall use the Current Procedural Terminology (CPT), Health Care Procedure Coding System (HCPCS), and UB-04 Data Specifications Manual (for a complete listing of valid revenue codes) and any subsequent editions in effect at the time of service. Provider(s) shall refer to the applicable edition for the code description, as it is no longer documented in the policy. If no such specific CPT or HCPCS code exists, then the provider(s) shall report the procedure, product or service using the appropriate unlisted procedure or service code.

#### *Unlisted Procedure or Service*

CPT: The provider(s) shall refer to and comply with the Instructions for Use of the CPT Codebook, Unlisted Procedure or Service, and Special Report as documented in the current CPT in effect at the time of service.

HCPCS: The provider(s) shall refer to and comply with the Instructions For Use of HCPCS National Level II codes, Unlisted Procedure or Service and Special Report as documented in the current HCPCS edition in effect at the time of service

- d. Modifiers - Providers shall follow applicable modifier guidelines.
- e. Billing Units - Provider(s) shall report the appropriate code(s) used which determines the billing unit(s).
- f. Co-payments -
