### **PHARMACY SERVICES**

WellCare of North Carolina pays for medicines covered by NC Medicaid, including many medications not listed on the NC Medicaid Preferred Drug List (PDL).

Note: NC Medicaid operates under an open formulary, covering all medications that are eligible for federal rebates per CMS.

#### **MAIL ORDER INFORMATION**

WellCare of North Carolina offers both retail and mail order services. To get started using the Express Scripts Home Delivery Service:

- >> Providers can electronically send or fax a new prescription to Express Scripts Pharmacy at 1-800-837-0959. (This number is for provider use only).
- **Members can request online at** <u>Express Scripts Home Delivery</u> to register or sign in if they have their member ID number ready and follow the guided steps to request a prescription. Once Express Scripts has the member's information, they will contact the provider for approval of their prescription.
- **Call Express Scripts Pharmacy at 1-833-750-4514 (TTY: 711)**. Express Scripts Pharmacy can contact the member's provider for a new prescription to be filled via mail order.
- Mail a home delivery order form. To get a copy of the form, register or log in at <u>Express Scripts Home</u> <u>Delivery</u>.
  - Go to the Benefit Menu, click Forms, and download the Home Delivery Order Form.
  - Complete the form and mail it with their paper prescription to Express Scripts Pharmacy.
- >> Important: Refills for controlled drugs, such as Alprazolam, Clonazepam, Pregabalin, Tramadol, Zolpidem, etc., will not transfer to Express Scripts Pharmacy. Members must obtain a new prescription from their doctor via one of the methods above.
