Upcoming Change: Provider Claims Appeal and Dispute Forms

Currently, there are three separate forms available for providers to submit claim appeals, disputes, or reconsiderations.

Beginning in April, these forms will be consolidated into one streamlined form to simplify the process and improve routing to the appropriate department for timely review. More details and instructions will be shared once the new form is launched.
